### OUR MISSION

The OCWLA is dedicated to advancing women in the legal profession by providing a professional network, raising awareness of discrimination and bias, and supporting charitable organizations.

### HISTORY

The Orange County Women Lawyers Association started in 1975 when five founding members determined that female attorneys needed a place to come together. At that time, there were no women jurists sitting on the bench in Orange County and women were openly discriminated against. Previously known as The Women and Individual Rights section of the Orange County Bar Association, OCWLA quickly expanded to over thirty members with the original goal of focusing on the rights of women and addressing discrimination.

In 1979, OCWLA became an affiliate organization of the Orange County Bar Association. Shortly thereafter, OCWLA aligned with California Women Lawyers, which in 1974 began its role as the only statewide women lawyers organization. OCWLA has continued to be a vital affiliate of CWL to this day.

Throughout the organization's 47 years, OCWLA's mission has remained true to the original goals – the advancement of women in the legal profession by providing a professional network, raising awareness of discrimination and bias, and supporting charitable organizations. OCWLA continues to advance this mission through networking events that foster collaboration and encourage leadership.
